# Permit Application

## **GUIDELINES – TRAVELLING CARNIVALS OPERATING THE CENTRAL BUSINESS DISTRICT**

### **BOOKING**

- 1) Carnivals are required to book the site at least three weeks in advance.
- 2) A permit application is required to be completed and received at the Council for assessment prior to approval being given. (The assessment will be based on the criteria set out within the Policy and these guidelines).
- 3) Only one carnival is permitted to operate at any one time.
- 4) A standard Alice Springs (Control of Public By-Laws) permit or a rejection letter, whichever the case, will be sent to the applicant within 4 working days of receipt of application.

### **THE SITE**

- 1) The only site available for carnivals in the CBD is on the Todd River bank, along side Leichhardt Terrace, in an area directly north of the public toilet (see attached map)
- 2) The site will have access to the public toilet, water and three phase power.

### **Permit Conditions**

- 1) The maximum period that a permit can be issued for is 3 calendar weeks.
- 2) Only one caretaker caravan will be permitted on the site during the validity period of the permit.
- 3) The carnival noise is to be at an acceptable level to neighbouring residences and businesses. Any complaints will be measured against the set out in the current Northern Territory Government Environmental guidelines.
- 4) The site is to be maintained in a clean and tidy state during the permit period.
- 5) A toilet key will be issued that will allow after hours use of the public toilet for the carnival and personal use. It is the responsibility of the permit holder to monitor, maintain and secure the toilets after hours.
- 6) Caretakers van is required to collect and dispose of waste grey water into the public toilet system.

### **Costs**

- 1) A charge per day will apply covering rental of the site, power and water, operation of a carnival and caretaker occupancy.
- 2) A deposit will apply and will require payment prior to setting up on the site. The deposit will be refunded at the expiry of the permit, when the toilet key is returned and the site is inspected.
