Use of Council Lawn Permit - Guidelines

Council Lawn Conditions

1. Council Lawn is to be left in a clean and tidy condition after use. If the area is not left clean and tidy after use, the refundable cleaning deposit will be forfeited.
2. No glass or ring pull containers allowed on oval/park and sale of food on satay sticks is prohibited.
3. The erection of tents or other structures is not permitted unless prior approval and site inspection through the Manager Infrastructure Operations is arranged.
4. Vehicles are not permitted on grassed areas.
5. Co-operation with other users who may have prior permission to use the Council Lawns during this time.
6. Users are asked to ensure noise levels are kept at an appropriate level in view of the close proximity of offices and businesses.

Equipment Conditions

1. Any damage or cleaning of the above facility will result in the forfeit of the refundable cleaning deposit.
2. Any extra charges will be debited to the above organisation/person hiring the Lawns.

Note for Food Stall holders:

Food stalls require a **Food Stall Permit** from Council. The Application for Food Stall Permit can be obtained from Council offices, or downloaded from Council's website at www.alicesprings.nt.gov.au/council/services/forms_permits.asp.
