Recently we've undertaken various litter and environmental initiatives, with the procurement and operation of the glass crusher just one of them. This membership club is the next stage of growth for the glass crushing facility and a great way for the corporate sector to contribute to recycling in our town.

Thanks for your interest in the "Council's Corporate Crushers Club". Without the support of the local business community Council would not be able to make these initiatives possible.

There are many benefits to becoming a member of the Council's Corporate Crushers Club and I encourage all local businesses to get involved.

Membership details

Alice Springs Town Council invites your company to become a member of the "Council's Corporate Crushers Club". For an annual members fee of just \$330 (including GST) corporate members will receive:

- A 50% discount over the landfill weighbridge for glass drink containers to go to Council's glass crusher.
- Monthly tracking of recycled amounts which are uploaded to the public "Council's Corporate Crushers Club" web page, so you can track and monitor your recycling progress.
- Largest contributors will be publicly acknowledged.
- Acknowledgement of your recycling contribution via Council publicity and events.
- Members will be given an ID card to be presented at the weighbridge at the time of deposit.

Terms and conditions of membership

- Membership is open to all local businesses that sell glass drinking products in Alice Springs (note: “local” is defined a business operating from premises within the Municipality of Alice Springs).
- Members must be registered as a Council credit account holder to participate in this membership program.
- The \$330 (including GST) annual contribution to the program must be paid in advance.
- Eligible participating members shall receive a 50% discount on the general waste fee for glass only (i.e. pay only \$45.00 per tonne or proportional percentage thereof for glass).
- A Council-endorsed Corporate Crushers Club ID must be shown at the weighbridge before a participating member can claim the discount.
- Glass crushing facilities hours of operation for the acceptance of glass under this membership program will be on Wednesdays from 9:00am to 2:00pm.
- Minimum load of 20 kilograms or 300 glass drink containers can be accepted per transaction at the Alice Springs landfill weighbridge.
- All glass loads delivered to the landfill via the weighbridge must be accepted by a Council staff member at the glass crushing facility.
- Any and all glass drinking containers will be accepted, but glass cannot be mixed with any other waste and no separation of mixed loads will be allowed to happen at the glass crushing facility.
- The membership fee of \$330 (including GST) per business goes towards publicity and promotion of the program and other club events or commitments.
- Data obtained as part of this program will be used for promotional purposes, including (but not limited to) publishing of data on the Council web site.
- Members must agree to be bound by these terms and conditions.
