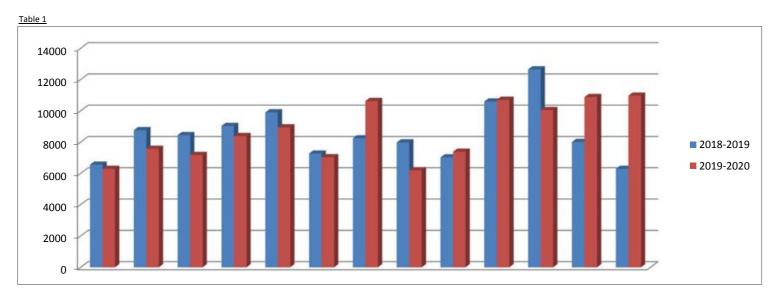
IMPACT ON CHANGE OF HOURS AT REDISCOVERY CENTRE

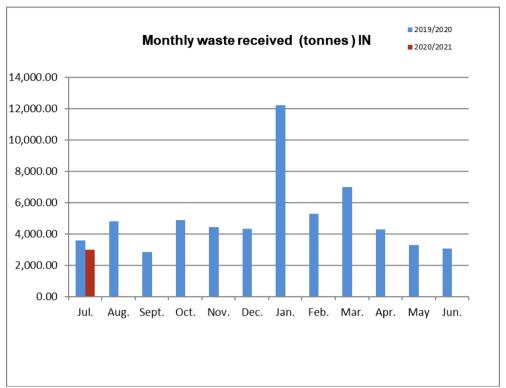

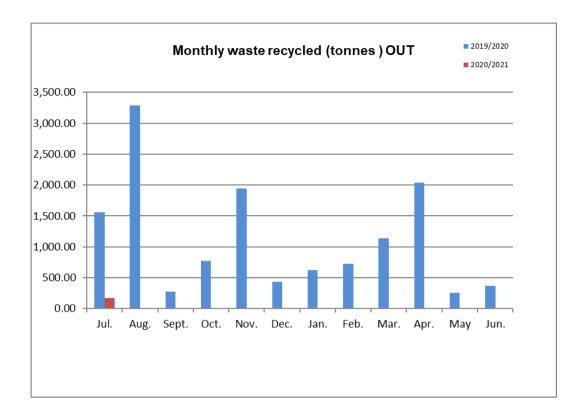

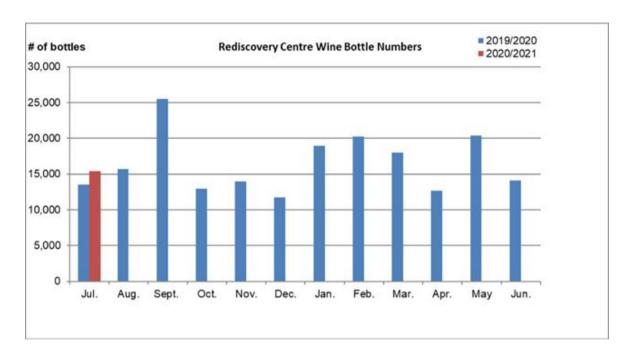

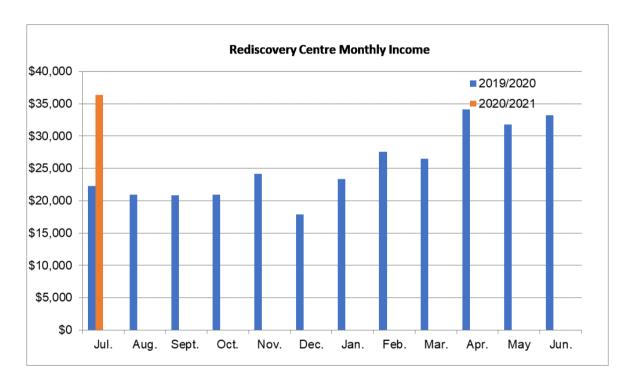
Rediscovery Centre:

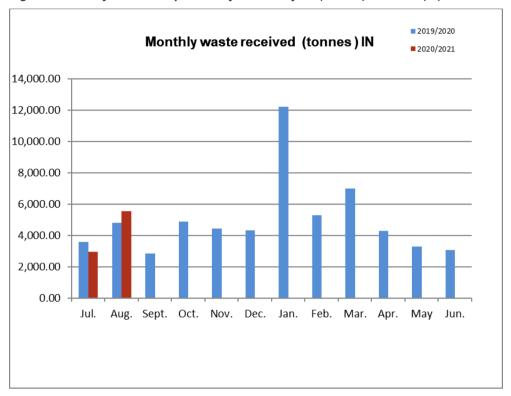

Figure 1: Monthly waste comparison by financial year (tonnes) received (IN)

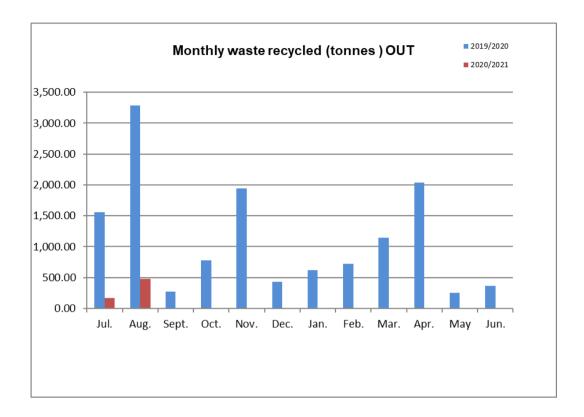

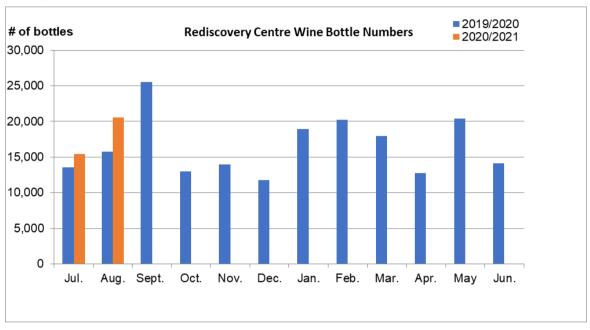

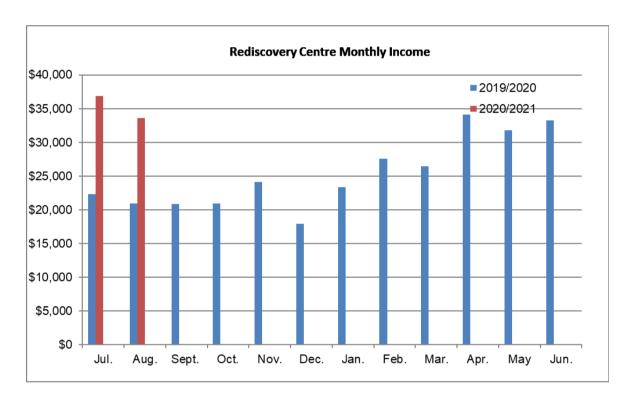

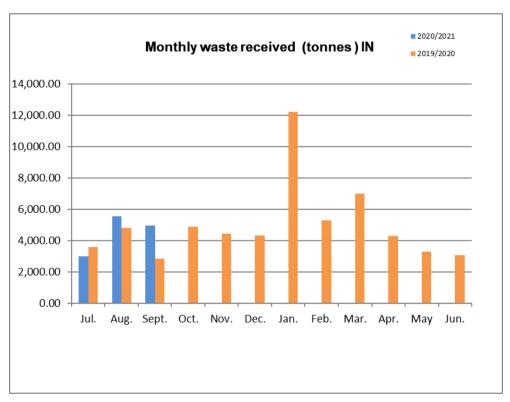

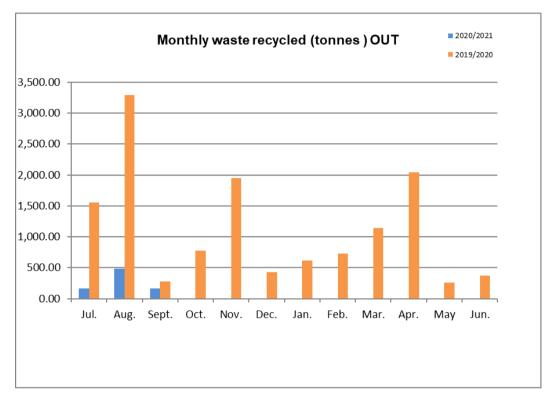

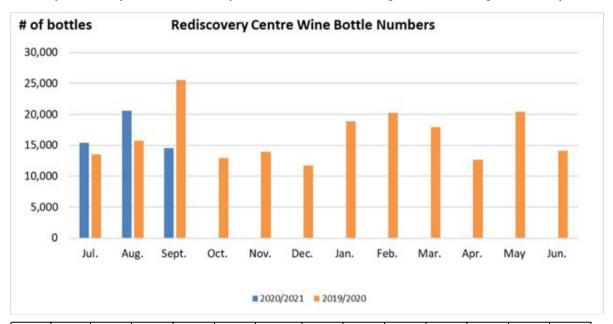

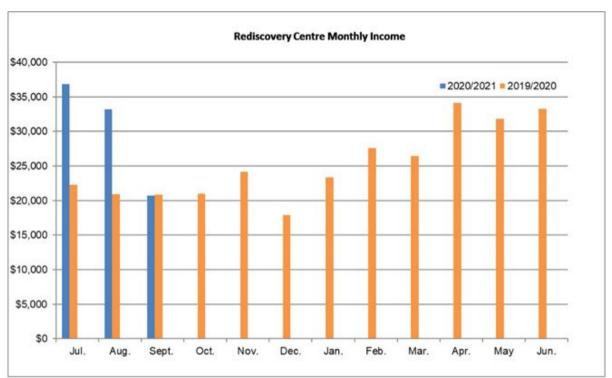
