4.1 Public Art Master Plan & Action Plan

Manager Community and Cultural Development advised that the 2nd Alice Upcycle Art Prize will occur this year. Expressions of Interest open on Monday 7 February 2022 with exhibition from 17 June to 3 July 2022. Promotion will occur in the following days.

4.2 PAAC Budget (Standing Item)

Manager Community and Cultural Development advised that the PAAC budget, after expenses and committed costs comes to a loss of **-\$6,980**.

The Committee agreed to seek additional funds from Council so that planned projects and activities in the Public Art Action Plan can be supported.

4.3 Terms of Reference

Manager Community and Cultural Development advised that the Terms of Reference for all Advisory Committees are being reviewed to align with the most recent Local Government Act and to look at the role of Elected Members to Advisory Committees.

Discussion ensued as to the relevance and goals of the Public Art Advisory Committee in the arts community and how it is going to move forward to the future.

Points of discussion include:

- Committee is still valuable and can still push forward more public art in an integrated way
- Public art is a lot more than visual art; it can be soundscapes, etc, and this can be discussed and expanded moving forward to the future
- Consider the make-up of the Committee, in terms of how decisions are made when assessing public art EOIs. Sometimes conversations are being led more from the Elected Members than the Committee member representatives from art organisations who are experts in their field.
- In terms of decision-making component, suggestion that a panel of a small group of people is easier to reach an outcome when making decision to determine artwork, than involving the whole Committee.
- Chairing component – getting feedback from each Committee member is important
- Goals and objectives and frequency of meeting of the Committee should be reviewed moving forward to make better use of the Committee members' time. At the moment, most of the objectives in the Terms of Reference are all operational.
- The Public Art Action Plan has merits to implement in alignment with the Public Art Master Plan moving forward
- Public art is important and should be represented with inputs from different art organisations
- Maintaining a group of skilled people through PAAC is important and has a significant role in implementing and advocating public art making sure it has a voice in the Council's process.
